College and Area Information:

Eastern Arizona College's District Offices are located in Thatcher, Arizona, a beautiful rural area with easy access to arid as well as mountainous recreation. The College is located approximately 125 miles northeast of Tucson and 165 miles southeast of Phoenix. EAC is a comprehensive community college offering five associate degrees across nearly 50 programs of study. Eastern Arizona College is the oldest member of the Arizona Community College system and is fully accredited by The Higher Learning Commission.

Position Summary and Organizational Relationship:

The Records Technician position reports to the Director of Records; Registrar and will perform a variety of administrative tasks in support of the department. This role will work closely with all departmental colleagues and other college personnel to facilitate the smooth functioning of the department. The position will also serve as a point of contact within the department, providing a high level of customer service as required to external bodies, and visitors. This is an important role that requires accuracy, attention to detail, a professional demeanor, and superior communication skills.

Required Qualifications:

- High school diploma or GED equivalent
- Experience with word processing, database, and spreadsheet software, specifically Microsoft Office applications.
- Experience with the proper operation and use of personal computers and standard office equipment.

Preferred Qualifications:

- Associate degree in education, business education or related field from a regionally accredited institution of higher learning recognized by the US Department of Education.
- Familiarity with student registration processes.
- Two or more years responsible clerical experience at a community college, preferably including student registration experience.
- Good organizational skills.
- Self-starter who works well under moderate supervision and with close co-worker relationships.

Essential Functions:

- Provides customer service for students, staff, and the public.
- Responds by email, phone, and in-person to students, staff and the public about college offerings, registration, admissions, and transcripts.
- Explain policies and procedures related to student records and processes.
- Be knowledgeable about college operations, regulations, and processes and assist in the completion of same.
- Perform data entry; ensure student information from admissions to registration is entered in compliance with federal and institutional guidelines.
- Assist in record management; alphabetize, file, scan, and ensure all records are accurate and up to date.
- Process the record's drop boxes and ensure student files are updated accurately.
- Maintains an accurate and up to date desk reference of procedures for accomplishing duties and responsibilities.
- Assist with end-of-the-year graduation duties, including the Graduation Ceremony.
- Provide Notary Public services.
- Performs other duties as assigned.
