

Position Open Notice Associate Professor of HVAC-R (ADC Tonto and FCI Prison Programs) Full-time

Safford, Arizona

College and Area Information:

Eastern Arizona College's District Offices are located in Thatcher, Arizona, a beautiful rural area with easy access to arid as well as mountainous recreation. The College is located approximately 125 miles northeast of Tucson and 165 miles southeast of Phoenix. EAC is a comprehensive community college offering five associate degrees across nearly 50 programs of study. Eastern Arizona College is the oldest member of the Arizona Community College system and is fully accredited by The Higher Learning Commission.

Position Summary and Organizational Relationship:

The HVAC Associate Professor reports to the Coordinator of Prison Programs. Funding for this position is contingent upon continuation of a contract with the Arizona Department of Corrections, the Federal Bureau of Prisons and continuation of this position/program within that contract. The selected candidate must be acceptable as an employee of the Bureau of Prisons, FCI and ADC Tonto Prisons.

Required Qualifications:

Required qualifications to effectively perform job. An equivalent combination of education, training, and experience will be considered.

- Five years verifiable occupational experience in HVAC or related areas
- Must pass an extensive background check by the Arizona Department of Corrections and Federal Bureau of Prisons
- Must pass a pre-employment drug screen required by the Arizona Department of Corrections and Federal Bureau of Prisons
- Ability to work effectively in a high-security setting with a diverse group of individuals.
- Ability to effectively utilize computer programs and productivity tools for communication, record keeping, supplemental instruction, instructional preparation, etc.
- Must be willing and able to work a non-traditional schedule that may include morning and afternoon classes.

Preferred Qualifications:

- Ability to work and interact effectively with Department of Corrections and Bureau of Prisons staff, College personnel, and students and be able to deal with the challenges and stress of a high security environment.
- Teaching experience in the HVAC trades and the ability to relate to and address all levels of student preparation.
- Currently licensed by the EPA in the HVAC trade or been licensed within the past three years with the ability to regain current status.
- Familiarity with and understand the Universal certification process.
- Proficient in enabling students to test and receive EPA certifications.
- Strong organizational and record keeping skills.
- Experience working in a high security environment with an all-male student clientele.

Essential Functions:

- Teach incarcerated adult male students approximately 5 hours a day, five days a week split between two different institutions.
- Adhere to a work schedule determined by the contracting agency that will include morning and afternoon classes.
- Teach proficiencies in focusses ventilation, and air conditioning trades and provide flexible learning opportunities in support of the program focus on HVAC systems and maintenance.
- Maintain true and accurate records reflecting student progress and achievement for all courses taught.
- Update course outlines, pre- and post-test and curriculum as needed.
- Comply with all Arizona Department of Corrections and Bureau of Prisons policy and procedures as well as all District policies and procedures.

 Perform other duties as assigned. Typical other duties may include advising students, serving on advisory committees, and program development and revision.

Knowledge, Skills and Abilities:

May be representative, but not all-inclusive, of those knowledge, skills, and abilities commonly associated with the job.

- Knowledge of heating, ventilation, and air conditioning systems, including installation, maintenance, troubleshooting, and repair.
- Excellent verbal and written communication skills for effective interaction with students, correctional staff, and college personnel.
- Understanding of industry standards, safety protocols, and regulatory requirements within the HVAC trade.
- Knowledge of Arizona Department of Corrections and Federal Bureau of Prisons policies and procedures
- Ability to work and interact effectively with Department of Corrections and Bureau of Prisons staff, college
 personnel, and students.
- Understanding of the Universal certification process and EPA regulations related to the HVAC industry.
- Knowledge of operating within a high-security environment, particularly in correctional facilities.

Physical Abilities

- Ability to handle and operate various HVAC tools and equipment precisely and safely.
- Physical stamina to teach and supervise hands-on activities for approximately 5 hours a day, five days a week, in different institutions.

• The primary work setting is within correctional facilities, specifically the Arizona Department of Corrections and Federal Bureau of Prisons institutions. This environment is highly secure, with stringent access controls, surveillance, and a need for adherence to strict security protocols.
