College and Area Information:

Eastern Arizona College's District Offices are located in Thatcher, Arizona, a beautiful rural area with easy access to arid as well as mountainous recreation. The College is located approximately 125 miles northeast of Tucson and 165 miles southeast of Phoenix. EAC is a comprehensive community college offering five associate degrees across nearly 50 programs of study. Eastern Arizona College is the oldest member of the Arizona Community College system and is fully accredited by The Higher Learning Commission.

Position Summary and Organizational Relationship:

The Tutor position reports to the SLC Tutoring Facilitator or the Director of Library if the Tutoring Facilitator is not available. The Tutor is responsible for providing students with individualized assistance to help them learn new concepts and complete assignments. This is an important role that requires accuracy, attention to detail, a professional demeanor, and superior communication skills. This is a part-time position generally consisting of no more than 19.5 hours per week as scheduled by the supervisor.

Required Qualifications:

Required qualifications to effectively perform job. An equivalent combination of education, training, and experience will be considered.

- Minimum of an AA or AAS degree; or equivalent combination of education, experience, and training.
- Applicant must have received a B in the class subject to be tutored.
- Willing and able to work a non-traditional schedule including evenings and weekends.

Preferred Qualifications:

- Previous tutoring work experience in the subject area, minimum of one year.
- Prior experience with Canvas, Gila Hank portal and EAC Monster Email or equivalent.
- Experience in a similar customer-facing role.

Essential Functions:

- Reviews and stays up to date with classroom curricula topics and assignments.
- Assists students with homework assignments, projects, test preparation, papers, and research.
- Teaches skills to help improve retention and academic achievement in a variety of community college classes.
- Provides students with positive and constructive feedback.
- Builds meaningful connections with students from diverse backgrounds.
- Recognizes different learning styles and preferences.
- Gives presentations, tours, and is involved in other programming activities as directed.
- Performs other duties as assigned.

Knowledge, Skills and Abilities:

- Proficient in using Microsoft Office 365 including Outlook, Word, and Excel, electronic communication and information tools and general office equipment with good typing and data entry skills.
- Ability to deal effectively with the public, including exceptional people skills.
- Ability to perform basic circulation duties using an integrated library system.
- Ability to start and complete projects with minimal supervision.
- Strong computer skills and ability to troubleshoot software.
- Comfortable supporting users with a wide range of computer skills.
- Excellent written and verbal communications skills.
- Ability to maintain confidentiality of patron records.

- Ability to maintain a neat and organized work and service environment.
