

Position Open Notice Tutor- Math/Science Part-time

College and Area Information:

Eastern Arizona College's District Offices are located in Thatcher, Arizona, a beautiful rural area with easy access to arid as well as mountainous recreation. The College is located approximately 125 miles northeast of Tucson and 165 miles southeast of Phoenix. EAC is a comprehensive community college offering five associate degrees across nearly 50 programs of study. Eastern Arizona College is the oldest member of the Arizona Community College system and is fully accredited by The Higher Learning Commission.

Position Summary and Organizational Relationship:

The Tutor for Math & Science position reports to the SLC Tutoring Facilitator or the Director of Library if the Tutoring Facilitator is not available. The Tutor is responsible for providing students with individualized assistance to help them learn new concepts and complete assignments. This is an important role that requires accuracy, attention to detail, a professional demeanor, and superior communication skills. This is a part-time position generally consisting of no more than 19.5 hours per week as scheduled by the supervisor.

Required Qualifications:

Required qualifications to effectively perform job. An equivalent combination of education, training, and experience will be considered.

- Proficient in the use of computer software including Google Docs, Sheets and Forms along with Microsoft Word, Excel, and Outlook.
- Proficient in the use of Canva design software and social media platforms.
- Ability to quickly learn computer programs.
- Strong customer service, communication, organization, and problem-solving skills.
- Ability to effectively manage frequent job interruptions, distractions, stresses, and seasonal fluctuations in workloads.
- Ability to be a self-starter.
- Demonstrated ability to function as an effective member of a large organizational team.
- Able to work weekends, evenings and nights as needed.

Preferred Qualifications:

- Previous tutoring work experience in the subject area, minimum of one year.
- Prior experience with Canvas, Gila Hank portal and EAC Monster Email or equivalent.
- Experience in a similar customer-facing role.

- Reviews and stays up to date with classroom curricula topics and assignments.
- Assists students with homework assignments, projects, test preparation, papers, and research.
- Teaches skills to help improve retention and academic achievement in math and/or science classes.
- Provides students with positive and constructive feedback.
- Builds meaningful connections with students from diverse backgrounds.
- Recognizes different learning styles and preferences.
- Provides workshops and study groups focusing on math and/or science principles.
- Teaches how to use mathematical software and tools.
- · Performs other duties as assigned.
